

Rules and regulations of the School Daycare Contest, part of the *Health Challenge*

Eligibility

1. This contest is open to school daycare services members and non-members of the *Association québécoise de la garde scolaire* (AQGS).
2. No purchase is necessary for this contest, which is intended for school daycare services participating in the *Health Challenge*.
3. The daycare services must be registered for the *Health Challenge* and must have initiated a process to meet the *Challenge*.
4. Participation to the *Health Challenge* is free and cancellable at any time. However, to be declared a winner, the daycare services drawn at random from among all the daycare services registered for the *Health Challenge* will be contacted with a series of questions to determine whether they have actually participated in the *Health Challenge*.

Registration

1. The *School Daycare Contest*, part of the *Health Challenge*, will be open from January 21, 2019 at 12 a.m. (EST) to March 1st, 2019 at 11:59 p.m. (EST).
2. All the school daycare services interested in participating in the *School Daycare Contest*, part of the *Health Challenge*, must register between January 21, 2019 at 12 a.m. (EST) and March 1st, 2019 at 11:59 p.m. (EST) by filling out the online form available at the gardescolaire.org website.

Description of prizes

Three (3) prizes, three (3) winning daycare services.

- Prize offered by Cardio Plein Air and Capsana

A training session by Cardio Plein Air and snacks (\$2,000 value) will be provided to a school daycare service that will have completed their registration between January 21, 2019 at 12 a.m. (EST) and March 1st, 2019 at 11:59 p.m. (EST). Certain conditions may apply.

- Prize offered by Les ateliers cinq épices

Cooking and nutrition workshops hosted by Les ateliers cinq épices (\$1,000 value) will be provided to a school daycare service that will have completed their registration between January 21, 2019 at 12 a.m. (EST) and March 1st, 2019 at 11:59 p.m. (EST). Certain conditions may apply.

- Prize offered by CATSPORTS

Sports and recreational equipment provided by CATSPORTS (\$600 value, issued as a gift card redeemable online at catsports.com) will be provided to a school daycare service that will have completed their registration between January 21, 2019 at 12 a.m. (EST) and March 1st, 2019 at 11:59 p.m. (EST). Certain conditions may apply.

Awarding of prizes and draw

- Capsana is the initiator of the *Health Challenge* and is the only entity responsible for the organization of draws, which will be conducted according to an extremely rigorous process under the supervision of a committee comprising internal representatives committed to the success of the *Health Challenge*. This committee is named the eligibility committee.
- Prizes must be accepted as they are described and awarded in the present Rules and regulations of the *Health Challenge*. They cannot be transferred or substituted with another prize, and are not exchangeable, in whole or in part, for a cash amount or another product. Capsana reserves the right to substitute a prize of equal value for another prize that cannot be awarded as outlined in the present Rules and regulations.
- Travel expenses associated with the prizes offered by Cardio Plein Air and Les ateliers cinq épices are the responsibility of Capsana.
- The odds of winning depend on the number of entries received during the contest period.

The prizes will be awarded in the following way:

- Prizes will be drawn among all the participating school daycare services in Quebec duly registered and awarded in this order:
 - First winner drawn: prize offered by Cardio Plein Air and Capsana
 - Second winner drawn: prize offered by Les ateliers cinq épices
 - Third winner drawn: prize offered by CATSPORTS
- The potential winning school daycare service will be contacted by phone or e-mail as of May 6, 2019, and will have to answer a series of questions to determine whether they actually participated in the *Health Challenge*.

Commitment of the winning daycare service

1. The names of the winning school daycare services will be posted on the healthchallenge.ca and gardescolaire.org websites as well as on the social media accounts of both companies.
2. A winning school daycare service must consent, if required, and without compensation, to have their name, photograph, voice, city and region of residence, and/or all declarations related to winning the prize, used by the organizers of the *Health Challenge* and its partners for communications and publicity purposes related to the *Health Challenge*. The names of the students will not be divulged without a prior agreement (release form).

Authority and responsibilities

1. Capsana has FINAL AUTHORITY regarding rulings and decisions concerning the registration of participating daycare services and the evaluation of the eligibility of potential winners of the *Health Challenge* contests, as well as the awarding of prizes.

Subject to the application of the Act respecting lotteries, publicity contests and amusement machines in relation to the present *Health Challenge*, any dispute regarding the organization or conduct of a promotional contest may be submitted to the *Régie des alcools, des courses et des jeux du Québec* for a ruling. Any dispute regarding the awarding of a prize may be submitted to the *Régie des alcools, des courses et des jeux du Québec* only for the purpose of attempting to settle it.
3. Capsana, its employees and consultants as well as the organizers, partners and sponsors of the *Health Challenge* CANNOT BE HELD LIABLE in the event of accident, loss or theft, or of any other problem or costs related, directly or indirectly, to the acquisition or use of a prize.
4. Taxes applicable under the Act respecting lotteries, publicity contests and amusement machines have been paid.
5. Refusal to accept a prize releases Capsana from any obligation related to that prize, including its delivery.
